POSITION INFORMATION

Position Summary/Purpose:

The Special Productions Intern supports programming, production, and community engagement work related to Washington Performing Arts Special Productions and Mars Arts DC. Special Productions are large-scale projects that involve cross-departmental collaboration to develop mainstage, community, education, and broadcast events based on a specific topic or theme. Previous Special Productions have included *Of Thee We Sing: The Marian Anderson 75th Anniversary Celebration* (2013/14), Wynton Marsalis' *Blues Symphony* (2014/15), *The Migration: Reflections on Jacob Lawrence* (2016/17), and *SHIFT: A Festival of American Orchestras* (2016/17 & 2017/18). Mars Arts DC is a creative platform for Washington Performing Arts and the D.C. community to celebrate and empower local artists through performances, unique educational programs, and interdisciplinary grassroots collaborations that showcase the diversity and vitality of our city. Reflective of our founder Patrick Hayes's motto, "Everybody in, nobody out," the Mars Arts DC program amplifies the role of local artists throughout Washington Performing Arts' productions, educational opportunities, and special events. Mars Arts DC also works closely with the education department to offer educational opportunities through Mars Arts DC.

Essential Duties to be Selected from the Following

The assigned duties may be adjusted to complement the intern's educational studies and interests

- Conduct research on potential artists, partner organizations, and venues in the D.C. metropolitan area.
- Participate in meetings and brainstorming sessions with Director of Special Productions and Initiatives and community partners
- Work with Director of Special Productions and Initiatives to identify and develop performance opportunities for community artists for current and future Washington Performing Arts seasons
- Support production needs and logistics for Special Productions & Mars Arts DC events
- Serve as an on-site lead for selected Mars Arts DC events
- Work with the Washington Performing Arts external relations department to publicize program events and ensure branding includes funder acknowledgements
- Collect supportive materials and work with the Director of Special Productions and Initiatives to develop reports for funders
- Support planning of residencies for selected mainstage concerts and special productions

- Liaise with colleagues in all departments on behalf of Special Productions & MUAI projects
- Assist with the preparation of event logistics, including drafting production documents and communicating with artists, vendors, and partners
- Conduct scholarly research, with guidance from the Director of Special Productions & Initiatives, in support of developing Special Productions
- Possible English to Spanish translation projects - Bilingual applicants encouraged to apply
- Event support during key events like Politics and Art on June 10, and others

Minimum Qualifications:

- Current enrollment in an undergraduate or graduate program (or recently graduated)
- Experience as a performer, visual artist, or in arts administration/production

Essential Capabilities & Preferences

The assigned duties may be adjusted to complement the intern's educational studies and interests

- Must be curious and enthusiastic about community arts
- Connection to the local arts community strongly preferred
- Ability to work independently and follow directions
- Strong organizational skills
- Strong communication and interpersonal skills
- Ability to learn quickly, handle a multitude of tasks, take initiative, and work independently with little supervision
- High level of energy and ability to work well in deadline and/or pressure situations
- Knowledge of the D.C. performing arts scene or the scene in other cities
- Experience with conducting scholarly research preferred

Specific Conditions of Work

- General office environment & work at various performance venues
- Ability to work flexible hours preferred, regular hours will be established, but support of selected evening and weekend events is encouraged to complement the educational experience.
 - Regular work hours will be adjusted in order to accommodate evening and weekend work
 - 15 to 20 hours per week required
- Able to lift up to 30 lbs.
