Position Title: Education & Community Engagement Intern

GENERAL INFORMATION: This volunteer internship program, geared toward undergraduates students, graduate students, and recent graduates, offers an educational opportunity to develop professional experience and knowledge in the area of education & community engagement at a performing arts non-profit. All volunteer interns who work for at least 15 hours per week for at least 12 weeks will be eligible to receive a stipend of \$500.

This internship may be fully in-person, mostly in-person with scheduled remote work days per week, or fully remote depending upon intern preference. If Washington Performing Arts' office status does not allow for in-person work at any point during the internship period, this internship will be fully remote. Regular hours during WPA's office hours will be established on an individual basis with each intern.

Fall internships run in concordance with typical university terms - September to December. Start/end dates determined with interns according to their schedules and commitments.

POSITION INFORMATION

Position Summary/Purpose:

This position provides overall administrative assistance to the Education & Community Engagement staff in support of the department’s various initiatives. The intern will support youth and adult education programs such as Concerts in Schools, In-School Artist Residencies, Capital Arts Partnerships, and Enriching Experiences for Seniors. Projects will also include community engagement programs such as the Feder Memorial String Competition, Misbin Chamber Music Competition, Family Art Moments, the Embassy Adoption Program, and other education department initiatives. The degree of involvement in these programs will be dependent on the ability to engage in-person with schools and community venues during the Covid-19 pandemic.

Essential Duties to be Selected from the Following

Assigned duties may be adjusted to complement the intern’s educational studies and interests.

- Providing assistance with overall administrative, logistical support, and production needs for Education & Community Engagement initiatives
- Communicating with school administrators, teachers, local artists, and organizational partners.
- Research and prepare for annual Feder Memorial String Competition and Misbin Memorial Chamber Music Competition
- Conducting research on potential community artists, potential partner organizations, and alternative venues within D.C.
- Observing Teaching Artists during residencies and performances

- Updating constituent information in Tessitura (database software)
- Working with the Washington Performing Arts Communications & Creative Media department to publicize program events and ensure branding includes funder acknowledgements
- Collecting supportive materials and working with the Education & Community Engagement staff to develop reports for funders
- Creating and/or revising program support materials, reports, teacher materials, and others
- Coordinating transportation, field trip opportunities, and other special events as requested
- Coordinating sign-up for select programs and maintaining Education & Community Engagement program calendars
- Support digital content creation and virtual programming (as determined by current Covid-19 and school operating status)
- Supporting and/or planning for department events like DCPS Honor Ensembles, competitions, EAP Mini United Nations, and more!

Minimum Qualifications:

- High School Diploma

Essential Capabilities & Preferences

- Interest/background in the performing arts from diverse global traditions
- Connection to and/or interest in the local arts community preferred
- Strong organizational and interpersonal skills
- Excellent oral and written communication skills
- Ability to learn quickly, handle a multitude of tasks, take initiative, and work independently with little supervision
- High level of energy and ability to work well in deadline and/or pressure situations
- Computer skills: Microsoft Word, Excel
- Some prior experience in an administrative setting preferred

Specific Conditions of Work

- General office environment and/or teleworking. This internship may be fully in-person, mostly in-person with scheduled remote work days, or fully-remote. If Washington Performing Arts' office status does not allow for in-person work at any point during the internship period, this internship will be fully remote.
- Occasional work in schools, performance venues, and event venues.
- Minimum of 15 hours per week required; regular hours during WPA's office hours will be established with each intern on an individual basis.

- Successful candidates may be required to complete a DCPS Volunteer Clearance after hiring - a requirement to engage in education activities with students.
- **COVID-19 Vaccination Requirement:** Washington Performing Arts values the safety of our employees and families, our patrons and visitors, artists and students, and the community at large. Therefore, effective October 15, 2021, we are requiring that all Washington Performing Arts staff (including contractors and vendors who interact in-person with the general public) must be vaccinated against COVID-19. The COVID-19 vaccines remain a critical tool for saving lives, reducing the severity of the illness in infected people, and stopping the spread of COVID-19. In support of these values, if you are selected for this internship, and your internship is not fully remote, you must be fully vaccinated against COVID-19 at the start of your internship. You must submit proof that you are fully vaccinated against COVID-19 to the Intern Coordinator on or before your start date as a condition of your internship. In the instance where vaccination is not medically advised or violates your sincerely held religious beliefs, you may ask for an accommodation to revise your internship to a fully remote internship. Accommodations will be granted depending on the essential duties and nature of the internship, and/ or do not cause Washington Performing Arts undue hardship. Additionally, Interns must follow any federal/state/local mandates (such as mandated mask wearing in public spaces) that may be in effect at the time of their internship, as well as any new policies or procedures enacted by Washington Performing Arts.
